SUBJECT: Consolidated List of Fees and Charges for Official Documents and Services

Supersedes: Marine Notice ADM-003, Dated 01/24 Rev.2

PURPOSE:

This notice updates Payment Instructions.

APPLICABILITY:

The Notice is for the information of all owners and potential owners and operators of Liberian flag vessels.

Delivery of documents:

Where applicable, documents will be delivered by email without need for courier fee.

If a hard copy of the document is required, a shipping and handling fee of US \$75 will be applied for each courier shipment. Multiple certificates will be combined when possible in one courier delivery to save cost.

Certificates and publications may also be picked up locally or sent by local courier from the Registry's regional offices. A shipping and handling fee of \$75 will be applied for each shipment picked up locally.

REQUIREMENTS:

The fees in the following Sections are to be remitted by credit card, wire transfer or check.

1.0 Statutory Initial Registration Fee and Annual Tonnage Tax

2.0 Marine Safety Inspection Compliance Program:

- 2.1 Annual fee for each vessel 500 gross tons or over for funding the Marine Inspection Compliance Program and matters related thereto, as provided by Maritime Regulation 7.191 and Maritime Fee and Taxes Regulation 9\$2,000 - \$2,500
- 2.2 Special Safety Inspection (SSI): unscheduled vessel inspection fee following detention, or to examine and report on the correction of deficiencies found during a flag State or port State inspection, or for the restoration of documents, etc., or for any additional urgent inspection requested by the operator... ..\$2,750
- 2.3 Bi-Annual Inspection: Applicable to vessels that have been detained by Port State Control, have been issued Flag state Operational Controls, either in the form of Flag State Control or Flag State Detention Letters and vessels registered on or after 1 June 2024 which have been accepted under special conditions\$2,000 - \$2,500
- 2.4 As indicated in Regulation 9 (5) of the Maritime Fees Regulations, the fee for Marine Inspection shall be adjusted in accordance with the inflation index in the form of the published Producer Price Index (PPI) of the United States Bureau of Labor Statistics with calendar year 1995 being the base year and \$1,200 being the base price. Such adjustments may be subject to a delay in application due to delay in the publication of such statistics.

The Office of the Deputy Commissioner will make this adjustment by amendment to this Marine Notice, effective from the date of publication of said amended Marine Notice.
